



2. **That with regard to Para 4.11(1)-** The Mising Agom Ke welcome the same provision but at the same time urged to execute the sai letter and spirit.
3. **That with regard to Para 4.11(2)-** The Organization has the op that the Third Language may also be introduced from the Lower Primary (at least from Class-II) along with the language of instruction and se language English, so that the students from mother tongue medium w mother tongue is not the regional language, can get an opportunitie learning the regional language for preparing himself/herself for the u primary level and secondary level. Otherwise the student who gets his / education in mother tongue, other than the regional language at the k primary level shall suffer at the upper primary and secondary level as there not be mother tongue medium school at the upper primary and secondary lev
