Sub: Our proposal for Language Policy of Assam

Sir,

The Mising Agom Kébang (Mising Sahitya Sabha) earlier submitted their proposal before the committee and to the Govt. of Assam for adopting a specific language policy in Assam. Here again, we reiterate the same proposals as follows:-

Mising Language should be introduced as medium of instruction at Lower Primary Level from the academic year, 2017 as per provisions of Art. 350A of the Constitution of India and Section 29 (2) (f) of Chapter V of the Right of Children to Free and Compulsory Education Act, 2009.

This proposal of Mising Agom Kébang, has been unanimously supported by all the national organizations of the Misings( copy enclosed)

Accordingly, the language policy would be as follows:-

#### 1. At Lower Primary Level i.e. from Class I to Class V

Medium of instruction - Mother tongue (The medium of instruction is also

2<sup>nd</sup> Language - Assamese i.e. regional language.

3<sup>rd</sup> Language – English (international language).

## 2.At Upper Primary Level i.e. Class VI- to VIII

Medium of Instruction - Assamese.

(The medium of instruction is the 1st language).

2<sup>nd</sup> Language - English.

3rd Language- Hindi i.e. national language

4th Language - Mising as Subject Language, (continuity of the teaching and learning),

# EXTRACT OF THE MEMORANDUM SUBMITTED TO THE HON'BLE EDUCATION MINISTER OF ASSAM AND THE HON'BLE CHIEF MINISTER OF ASSAM ON 16.06.2016 AND 17.06.2016 RESPECTIVELY.

### 2. MISING LANGUAGE:

The Mising Agom Kebang had entered into a Memorandum of Understanding first in 1985 with the Congress Govt. led by Late Hiteswar Saikia and then again in 1986, with the new Govt. led by Asom Gana Parishad for introduction of the Mising Language in Class III and IV on experimental basis and then to introduce the Mising language as Medium of Instruction at primary level. Since then, 230 Nos. of posts of Mising Language Teacher (MLT) have been created and teachers appointed till 1994 and thence, the process of appointing MLT has come to a complete halt. The understanding of introducing the Mising language as medium of instruction never took off.

In view of the prevailing situation, we unanimously raise before your honour the following demands:

2.1. The Mising Language should immediately be introduced as medium of Instruction in lower primary (class I to V), in all the areas predominantly inhabited by Mising people under the provision of Article 350 (A) of the Constitution of India, Chapter V (29) (2) (f) of the Right to Education Act, 2009 and recommendations of the National Education Commission, National Counci of Educational Research & Training (NCERT).
